The Law School Board decided to open the contest for the tenure of an Assistant Professor position - Position 8 on the Post List of the Law Sciences Department, second semester 2010-2011.

**1. DESCRIPTION OF THE POSITION OPENED FOR COMPETITION**

The aforementioned position contains two disciplines:

- European Political Institutions;
- Contemporary Political Systems.

**2. DUTIES ENSUING FROM THE SPECIFICITY OF THE POSITION OPENED FOR COMPETITION:**

a) Didactic activity:

- European Political Institutions (2h course- 1h seminar, Second year, second semester, Specialty Law License, with one course Series and five Seminar groups; total conventional hours: 4.5);
- Contemporary Political Systems (2h course- 1h seminar, Third year, first semester, Specialty Law License, with one course Series and five Seminar groups; total conventional hours: 4.5);

b) **Scientific Research Activity:** 338 classes; the publication of minimum two papers in BDI/B+ reviews or a paper welcomed in an ISI publication. Amongst the articles / published studies, at least one should be published in the reviews supported by the University "Petre Andrei" of Iași.

c) **Evaluation Activity:** exams, colloquies or projects; evaluation as such and arrears.

d) **Student tutoring/ advising for Diploma Paper writing:** minimum five students/ papers included for the position.

e) Course aids or handbook for every didactic subject included in the position.

**3. THE MINIMUM SALARY OF THE JOB AT THE EMPLOYMENT MOMENT: 1650 ron.**

**4. ISSUES FOR COMPETITION:**

The candidates shall carry through a public lecture of minimum 45 minutes, which shall contain the following eligibility features:

- a) professional competences that recommend the candidates to be employed (didactic experience; list of relevant publications; scientific research);

b) the career and the future individual plans concerning professional evolution.
