**THE DESCRIPTION OF THE POSITION**

**I. The description of the position for the contest:**

The position of *University Professor*, position 2 from the status of the Faculty of Law, specialisation Law, form of education with frequency, The Department of Judicial Sciences, contains the following disciplines:

- Private International Law (undergraduate course);
- International Commercial Law (optional undergraduate);
- Commercial Law (undergraduate course);
- Competition Law (undergraduate course)

**1. The responsibilities / the activities designed for the position regarding the contest:**

- Scientific activity (no. of course hours/seminars, year of study, number of study groups, number of conventional hours per each subject):
  - 2 hours of course, 3<sup>rd</sup> year of study, 1 study group, 2 conventional hours per course;
  - 2 hours of course, 3<sup>rd</sup> year of study, 1 study group, 2 conventional hours per course; -
  - 2 hours of course, 1 hour of seminar, 2<sup>nd</sup> year of study, 1 study group, 3 conventional hours per course.
- Scientific research activity (number of hours, minimum number of articles, papers, participations in scientific manifestations etc.):
  - 400 hours, presented in the Position Paper, works/monographies, articles which represent contributions in extenso, published in scientific reviews with a highly acknowledged prestige in the domain of judicial sciences or indexed in international acknowledged data basis, studies in collective works or in the papers of the conferences which represent contributions in extenso, published in highly prestigious publishing houses from the domain of judicial sciences, numerous participations in national and international conferences;
- The assessment activity (written examinations, oral examinations, projects etc.):  
written examination of the discipline: Private International Law (undergraduate course); International Commercial Law (optional undergraduate); Commercial Law (undergraduate course); Competition Law (undergraduate course)
- Coordination activity of Diploma License Papers / Dissertation Papers (where necessary):
  - I have coordinated over 15 Diploma License Papers / Dissertation Papers annually

- Written course or students book for the discipline under discussion:
